



## Forbes Australia Leadership Forum – February 2024

### 1. Terms and Conditions

(a) You are entering into a transaction (the **Transaction**) with Success Publishing Pty Ltd (hereinafter referred to as '*Forbes Australia*') to purchase a package known as the 'Forbes Australia Leadership Forum Package' (the **Package**), entitling you to the benefits set out in section 3 below.<sup>1</sup>

(b) By proceeding with the Transaction and making a payment, you confirm that you:

(i) have read, understood, and agree to these terms and conditions.

(ii) agree to the privacy policy of Forbes Australia – <https://forbes.com.au/privacy-policy>

(iii) agree to the conditions of entry set by the venue at which the Forbes Australia Leadership Forum will take place, being Pier One, Walsh Bay, 11 Hickson Rd, Dawes Point NSW 2000.

(iv) acknowledge and understand it is incumbent upon you to provide Forbes Australia with full and accurate details of each attendee as required under section 4, failing which you may not receive the benefits to which you may otherwise be entitled.

(v) agree that whilst the advertised line up & agenda is correct at release, it is subject to change without notice and that you will have no claim against Forbes Australia either for refund of the price of the Package or for any other claim whatsoever.

### 2. Payment

(a) You agree:

(i) to pay Forbes Australia in full, when placing an order to purchase a Package.

(ii) until payment has been completed in full, you will not be entitled (nor able) to receive any of the entitlements comprising the Package.

(b) All pricing is in Australian Dollars and inclusive of GST

### 3. Package Entitlements

(a) You will receive the following entitlements (**Entitlements**):

#### **4. Requirements of Purchase**

(a) A name, contact number & email address will be required for the purchaser of each Package purchased.

(b) When entering the Pier One, Walsh Bay photo identification may be requested & must match the name on the ticket to guarantee entry.

#### **5. Cancellation Rights**

(a) Note that there is no cooling-off period and unless the Forbes Australia Leadership Forum event is cancelled by Forbes Australia, payment for a Transaction is not refundable.

(b) If the Forbes Australia Leadership Forum event is postponed for any reason, your entitlements will apply to the rescheduled event. A rescheduled event will be provided to you before February 27<sup>th</sup>, 2025.

(c) If the Forbes Australia Leadership Forum event is cancelled for any reason, you will be entitled to a refund of the price of the package but will have no other claim of any nature arising out of such cancellation.

(d) Entitlements not used are not able to be swapped or exchanged for credit.

(e) If you purchase your Package via the telephone, you will have 10 business days from the date of purchase to cancel your purchase & obtain a full refund.

(f) Should you qualify for a refund, the amount will be refunded within 21 business days from cancellation.

(g) If you have used or accessed any of the entitlements comprising the Package, Forbes Australia reserves the right to deny you a refund in respect of the utilised portion or deduct reasonable costs for the amount returned to you.

#### **6. Package Resale**

(a) The re-sale (or offer for resale) of Entitlements is strictly forbidden.

(b) If any Entitlements are found to be listed for re-sale, Forbes Australia reserves the right to cancel all Entitlements without refund and the bearer of the Package will not be provided with Entitlements.

(c) Only Forbes Australia Leadership Forum package purchases made directly through Forbes Australia will be guaranteed access to the Entitlements listed in section 3.

#### **7. Force Majeure**

(a) If the Forbes Australia Leadership Forum event has to be re-scheduled, postponed or cancelled as a result of an act of God, Government legislation, public health orders, an inevitable accident, power cut, fire, blackout, flood, COVID-19, pandemic, injury, death or any other calamity, or if by reason of strikes, or lockouts, or any other events beyond the direct control of either party, Forbes Australia reserves the right to postpone and reschedule the event and the provisions of section 7(b) or 7(c), as the case may be, will apply.

(b) Forbes Australia reserves the right to alter the venue, speakers and amend the agenda due to circumstances outside of its control-

(c) Forbes Australia will not be liable in any manner whatsoever for any cancellation or postponement of the Forbes Australia Leadership Forum event as a result of Force Majeure or a change of venue or amendment to the agenda arising out of this clause 7.

#### **8. Privacy and your security:**
